# **Covid restrictions**

As I am sure you are all aware on Monday 21st June there may be some relaxation of the current restrictions. With nursery having a rigorous covid safe policy from the very beginning, i.e., our 14-day isolation period, we have avoided having to close. There have been a few occurrences whereby if children had returned to nursery under the government's guidelines of a 10-day isolation period they may have spread the virus and the nursery would have been closed for 14 days. Consequently, I will not be allowing parents into nursery until at least September, as not all of the staff have received their first vaccination. I thank you in advance for your understanding in this matter.

# <u>Parents Evening</u>

Unfortunately, yet again this term we will not be able to hold a face-to-face parents evening, and instead your child's keyperson will telephone you at an arranged time. (To be arranged in due course) Staff will upload children's reports to children's learning journey's so that parents can read through and ask any questions during the phone call. A signature will be required from parents whose children are leaving for school, so that we can send their reports to their new teacher.
